Do you qualify for the Earned Income Tax Credit?

You do if you earn less than...

- **\$43,279** and have three or more qualifying children
(**\$48,279** if married and filing jointly)
- **\$40,295** and have two qualifying children
(**\$45,295** if married and filing jointly)
- **\$35,463** and have one qualifying child
(**\$40,463** if married and filing jointly)
- **\$13,440** and don't have a qualifying child
(**\$18,440** if married and filing jointly)

YOUR REFUND MAY BE AS MUCH AS:

- **\$5,657** if you have three or more qualifying children;
 - **\$5,028** if you have two qualifying children;
 - **\$3,043** if you have one qualifying child; or
 - **\$457** with no qualifying children

[Required Items for Completing an Accurate Return](#)

- Proof of identification for yourself and/or your spouse
- Social Security Cards for all individuals in household
- Individual Tax Identification Number (ITIN) Verification letter issued by the Internal Revenue Service (IRS)
- Birth dates for all individuals in household
- Wage and earning statement(s) from all employers (**Forms W-2, W-2G, 1099-R**)
- Interest and dividend statement from banks (**Form 1099**)
- Bank routing numbers and account numbers for direct deposit
- Other relevant information about income and expenses
- Total amount paid for day care and the day care providers' Tax Identification Number (the individual's social security number or the business' Employer Identification Number)
